- *Food, toy, petting and/or verbal praise are allowed

*Points accumulate towards titles. Titles require 300 points. 100 points are available each run.

Come and have FUN with your dog!

Eligibility - Any and all dogs that are 6 months or older, on the day of the trial are eligible to compete. All Dogs must have their current Rabies Vaccination and other vaccinations recommended by your veterinarian.

Abilities - Deaf dogs, 3 legged dogs and dogs in wheelchairs are allowed. Dogs in heat run at the end of the class and must wear panties.

Handlers - Anyone over the age of 5 years.

Registration - Dogs must be registered with Happy Ratters. It is \$15 to register a dog for their lifetime. <http://www.happyratters.com/registration/>

Awards - Placement ribbons will be awarded for 1st -3th place. Ribbons will be awarded for Q's in all classes. Title ribbons will also be awarded. Special high point awards will be awarded included fastest dog in class.

Fees: All classes: \$18 each. We prefer NOT to run credit cards as it incurs additional fees. If this is the only way that a person can pay, it is up to the person to call the office and leave credit card information. Please send a check or money order if at all possible, made out to Paws 'N Effect and sent to Paws % Sandy.

Register for Trial: You can register for this trial by completing this registration form and mail it to the Trial Secretary along with your payment made payable to **Paws 'N Effect**. Entries are on a first-received basis and payment must be received by closing date. Withdrawals after the closing date due to injury or sickness of the dog will be eligible for 75% refund of entry fee paid upon receipt of a note from your veterinarian.

Collars Dogs must be off leash and run naked during their run. All dogs must be leashed at all other times. **We do not allow prong collars, scent release collars, electronic, or choke collars on the grounds at any time.**

Crating Climate controlled indoor crating is available at this location site. Please bring your own crate and a waterproof tarp to place under it. You may also crate out of your car.
