For the Standard/Regular class/es, all dogs will start at the Ratter Level, but dogs with a Barn Hunt Association Open title or higher, may begin trialing at the Expert Level if they prefer.



<u>Eligibility</u> - Dogs that are <u>6 months or older</u>, on the day of the trial, are eligible to compete for titles. All Dogs must have their current Rabies vaccination and other vaccinations recommended by your veterinarian.

<u>Abilities, Bitches in Season</u> - Deaf dogs, 3 legged dogs and dogs in wheelchairs are allowed. Bitches in season are eligible to enter the trial but must be kept separate from other dogs, will run at the end of their class/trial, and must wear panties. If you are bringing a bitch in season, please advise the trial secretary prior to the trial and inform exhibitors at the Judge's briefing.

<u>Registration</u> - Dogs <u>must</u> be registered with Happy Ratters to compete at trials. It is \$15.00 to register a dog for their lifetime. http://www.happyratters.com/registration/

<u>Awards</u> - Ribbons will be awarded for Q's. Placement ribbons will be awarded for 1st -4th place. New Title ribbons will also be awarded.

<u>Collars</u> - Dogs must be off leash and run "naked" during their run. All dogs must be leashed at all other times. Prong, Choke, Pinch, or electric collars are not allowed in the staging area or on the way from the staging area to the ring.

<u>Crating</u> - There will be room for inside crating at this facility.

Parking & Accessibility - Ample parking is available close to the facility.

<u>Food</u> - Numerous pizza, sub shops, and burger restaurants are within a five mile radius of Genesee Community College. Also, there will be an opportunity for people to pre-order a boxed lunch which will be available right at the trial site.

<u>Facility and Bathrooms</u> - Genesee Community College is climate controlled for heat and air conditioning and provides restrooms. Stairs or elevator use required to access crating and searches.

Turn right onto West Saile Road (Airport Road) and continue to Bank Street. Turn right on Bank Street. After crossing over the Thruway again, turn left onto Assemblyman R. Stephen Hawley Drive. Genesee Community College is located on the left.
