**Please review it before attending the Trials**

For the Standard/Regular class/es, all dogs will start at the Ratter Level, but dogs with a Barn Hunt Association Open title or higher, may begin trialing at the Expert Level if they prefer.

**Eligibility** - Dogs that are **6 months or older**, on the day of the trial, are eligible to compete for titles. All Dogs must have their current Rabies vaccination and other vaccinations recommended by your veterinarian.

**Abilities, Bitches in Season** - Deaf dogs, 3 legged dogs and dogs in wheelchairs are allowed. Bitches in season are eligible to enter the trial but must be kept separate from other dogs, will run at the end of their class/trial, and must wear panties. If you are bringing a bitch in season, please advise the trial secretary prior to the trial and inform exhibitors at the Judge's briefing.

**Registration** - Dogs **must** be registered with Happy Ratters to compete at trials. It is \$15.00 to register a dog for their lifetime. <http://www.happyratters.com/registration/>

**Awards** - Ribbons will be awarded for Q's. Placement ribbons will be awarded for 1st -4th place. New Title ribbons will also be awarded.

**Collars** - Dogs must be off leash and run "naked" during their run. All dogs must be leashed at all other times. Prong, Choke, Pinch, or electric collars are not allowed in the staging area or on the way from the staging area to the ring.

**Crating** – You will crate your dogs in your car. May can be chilly in western, NY so be sure to dress accordingly and bring appropriate gear to keep your dogs comfortable in your cars.

**Parking & Accessibility** - Ample parking is available close to the facility.

**Food** - The Ischua Paws 'n Play is a private training facility without outside food vendors or nearby restaurants. Trial participants should be prepared to bring their own lunch. Water and packaged snacks will be provided by the facility.

**Facility and Bathrooms** - The Ischua Paws 'n Play is a climate-controlled facility with heating and air conditioning to be used as needed. There is a restroom available for use in the office building.

**Emergency Vet** - Emergency Veterinary Services are available Saturday and Sunday 10:00 am until 8:00 pm at The Enchanted Mountain Urgent Vet Care, 700 W State Street, Suites 5 and 6, Olean, NY 14760, (716) 257-4830

**Volunteers** - Volunteers will help our Trials run smoothly. We need Gate Stewards, Score Runners, Rat Wranglers and Others. No experience required! We will teach you!

**Directions - From the South:** From I-86 (from either direction) take exit 27. Head north on Route 16 toward Franklinville. Travel 5.7 miles and turn left onto Mill Street. Shortly after turning onto Mill Street, you will take a right onto Baxter Mill Road (there is a house with a white fence on the corner that will be on your left when you make the turn). After a short distance, the road splits. Veer left to stay on Baxter Mill. You will cross a one-lane bridge and railroad tracks and find yourself on a gravel road. The Ischua Paws 'n Play is about 1 mile from the bridge. **From the North:** Head south on Route 16 toward Olean. After you go through Franklinville, you will travel 7.5 miles and take a right onto Mill Street. Shortly after turning onto Mill Street, you will take a right onto Baxter Mill Road (there is a house with a white fence on the corner that will be on your left when you make the turn). After a short distance, the road splits. Veer left to stay on Baxter Mill. You will cross a one-lane bridge and railroad tracks and find yourself on a gravel road. The Ischua Paws 'n Play is about 1 mile from the bridge.

**Accommodations** - Hotels are within 20 minutes of the facility. Rates and pet policies change. Please call for current availability, rates, and pet policy of the hotel.
